# Meet Inspira Financial - The New Home for Your RRA

On January 17, 2024 PayFlex was rebranded to Inspira Financial. Inspira provides health, wealth, retirement, and benefits solutions that strengthen and simplify the health and wealth journey relentlessly pursuing better outcomes for all with health savings accounts.

There's no change to how you submit claims or how you will be reimbursed for expenses. Your PayFlex username and password will still work. Processes haven't changed and the only change was to the name.

You can pay your insurance premiums and other eligible medical expenses and then request reimbursement from your RRA.; or you can pay your eligible insurance premiums directly from your Retiree Reimbursement Account (RRA) setting up a request for a one-time payment or automatic monthly payments.

When requesting a reimbursement, you can submit an eligible claim on the Inspira member website or you can complete a paper copy of a Health Reimbursement Arrangement

(HRA)/Retiree Reimbursement Arrangement (RRA) Claim Form (copies are on the website); and mail or Fax it to Inspira.

# As with PayFlex and WageWorks before them, all reimbursement claims must include proof of payment.

If you don't already have an email on file with Inspira (PayFlex), it is a good idea to provide Inspira with an email contact. You may recall that the address to mail claims did change back during the summer and communication went out to those retirees who had emails on file. All Claim Forms on the website have been updated with the new mailing address. If you, like many of us make multiple copies of blank claim forms, please toss them or make sure you use the updated mailing address when you are filing claims. # DEAR and NRLN — YOU ASK WHY ??

Based in Washington, D.C., the National Retiree Legislative Network (NRLN) is a non-partisan, grassroots coalition representing more than 2 million retirees who came to the NRLN from nearly 200 different U.S. corporations and public entities. NRLN and its members advocate and/or lobby on behalf of retirees in a majority of U.S. Congressional Districts across the country. They are working together as NRLN Individual Members, Retiree Associations (like DEAR) and Chapters to preserve the retirement benefits they earned during their many years of employment. NRLN is the only nationwide organization solely dedicated to representing the interests of retirees and future retirees. Annually NRLN sponsors a 'Fly-In' when members join NRLN on visits to Representatives and Senators and advocate for retiree issues.

Based in Michigan, DEAR is a Michigan organization representing almost 11,000 retirees from DTE and its wholly owned subsidiaries formed to preserve the retirement benefits earned while they were employees of DTE. DEAR joined NRLN as a Member Association early in our existence and has held a seat on the NRLN Board of directors for over 20 years with its president or a board member serving on the NRLN board. Former Board member Bob Foresta and Past President Bob Tompkins served on the NRLN Board and currently President Janet Seefried serves on NRLN Board. Both Bob Tompkins and Janet took on the role of NRLN Treasurer while on that Board. And, as you know, DEAR also participates in the Annual 'Fly-In'.

The DEAR/NRLN partnership is the best way for DEAR to keep our issues in front of our elected leaders and for us to stay in touch with, and better understand, what is happening, or not happening, in D.C. that impacts our benefits.

# NRLN LEGISLATIVE AGENDA 2024 – A SUMMARY

The NRLN legislative agenda is a set of legislative proposals developed by NRLN to address concerns of retirees from more than 400 U.S. companies and public utilities – that's us. The full agenda focuses on retirees and on Income Security (including Social Security) and Healthcare Security (including Medicare). The agenda is revised annually and as/if any new issues arise.

Each year, agenda proposals are fully reexamined and prioritized. The top proposals are supported by detailed White Papers and brief Executive Summaries and/or Position Papers that are posted on the NRLN website www.nrln.org. A set of one-page Talking Points is also developed for each of the top priorities and they are used as an advocating or lobbying aid in Washington D.C. and throughout the NRLN Grassroots Network in all 50 States – that's us.

Annual preparations, prioritizing of objectives and grassroots advocacy and /or lobbying has proven to be an effective and economical way to represent retirees and has earned recognition for the NRLN as an effective retiree advocacy organization. This information is used by DEAR and other NRLN members on the 'Fly-Ins' and for local conversations with our Michigan elected officials.

NRLN finds that retiree issues they address (like the high cost of healthcare and income security) are tied to savings and overall preparations to retire which also affect many Americans under age 65 today.
